MPCL Flood Relief And Rehabilitation Program



586 Million

MPCL spent on Flood Relief and Rehabilitation Activities since June 2022.

Background

The 2022 floods in Pakistan exposed the country's vulnerability to climate change despite contributing less than one percent of global greenhouse gas emissions. The scale of the disaster was immense, with one-third of the country submerged, 33 million people affected, and nearly 8 million people displaced. This situation required strategic coordination to effectively link and transition from humanitarian response to rehabilitation.

MPCL's Commitment & Strategy

Demonstrating solidarity during this national level crisis, MPCL instantly responded to this calamity in its own area of responsibility, in the most comprehensive manner by providing all out support to the displaced populace. In response, MPCL devised a three-pronged strategy;

- Integrate and synchronize indigenous flood relief efforts with established Army relief apparatus.
- Direct engagement with local affectees by mobilizing MPCL field teams and resources to provide immediate humanitarian assistance to locals.
- Orchestrate an effect-based rehabilitation program to undertake major infrastructure development works to enable early return of displaced populace.

MPCL spent Rs 586 Million on Flood Relief and Rehabilitation Activities since June 2022.

Flood Relief Activities

MPCL prioritized the provision of essential supplies, like food items, clean drinking water, tents, and mosquito nets, to the displaced families. In Sindh and Balochistan, MPCL provided rations packs to 3150 families, 10,000 cooked meals through Mari Mobile Dastarkhawan in Nowshera and Charsadda, treated over 5500 patients in multiple medical camps. Moreover, MPCL played a vital role in restoring infrastructure by pumping away floodwater from low-lying areas and swiftly repaired several kilometers of access roads around their operational areas





MPCL Flood Rehabilitation Program

Rehabilitating the local populace in their areas remained a monumental challenge. The floods caused extensive damage, impacting health facilities, disrupting the education of thousands of children, and jeopardizing access to clean water and essential transportation routes: a coordinated effort at all levels became imperative to address this crisis and prevent further hardship.

MPCL allocated Rs 333 Million to undertake following projects:



Construction of two Water Filtration Plants and water supply scheme at Mach, Balochistan



Rehabilitation of Schools and Civil Hospital / Dispensary at Mach, Balochistan



Provision of 250 Specialized Water Filtration Coolers in Mach, Balochistan



Reconstruction of Damaged Houses in Abegum (Mach), Balochistan



Construction of Water Supply Scheme and renovation of damaged mosque in Maiwand, Balochistan



Rehabilitation of Junior School, Govt Boys School and Basic Health Unit in Baranabad, Sujawal (Sindh)



Conclusion

Despite the initial response, the stark reality remains: an estimated 20.6 million people, including 9.6 million children, still face dire circumstances and depend on continued humanitarian assistance. Fueling hope for the future, MPCL prioritizes long-term support, from immediate relief to rehabilitating vital infrastructure like health clinics and schools, for displaced families.

- 2) One day salary contribution of the staff members Rs. 1.28 million.



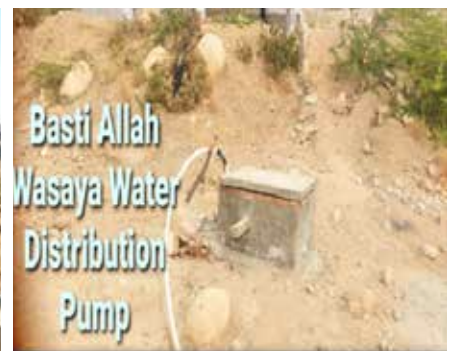

Being the Operator of DG Khan Block, POL took it upon itself to help the locals overcome this crisis by supplying clean drinking water for the surrounding communities of the area, and on a priority basis, POL installed Two (02) Solarized Submersible Water Pumps in Basti Mehmod Mujawar & Basti Haji Allah Wasaya Mujawar Mouza Gidi, UC 97 Tumman Leghari Zareen, District Dera Ghazi Khan at a total cost of Rs.4.300 million.





Flood Relief Work By Orient Petroleum In District Dadu

It is Orient Petroleum's belief that education is a universal right and that everyone should have unhindered access to quality education. We supported a variety of educational initiatives to ensure the workforce of the future is productive.

Orient Petroleum extended support to upgrade existing schools as well as set up new educational facilities. Orient Petroleum also helped in reviving state-owned educational facilities that were completely shut down. Over 2,200 girls and boys were enrolled in these schools receiving primary and secondary education. Moreover, these schools have also employed around 85 female teachers.

Provision of Healthcare

PPL is one of the leading national E&P companies with a diverse portfolio, comprising gas, oil and minerals, with assets located all over the country as well as in Abu Dhabi, UAE and Yemen. The company also has working interest in Reko Diq project.

The company's corporate philanthropic contribution dates back to the mid-1950s, when Sui Model School (SMS) was established for children of staff and locals. Since then, PPL has managed an integrated, multisectoral CSR program for over 60 years aimed at enhancing the quality of life for deserving communities in both remote operational areas as well as urban centres. The primary focus continues to be on projects in education, healthcare, livelihood generation, infrastructure development and post-disaster rehabilitation.

The company dedicates at least 1.5 percent of its annual pre-tax profit for CSR initiatives that touched Rs. 2.1 billion in 2021-22, which is a record spending. Apart from its ongoing projects, the company has supported communities hit by flash floods in 2022 to supplement government's efforts.

For the recent floods that led to over 1700 deaths and affected nearly 33 million people, PPL donated over Rs. 70 million. The company collaborated with Provincial Disaster Management Authority (PDMAs) to support their relief efforts. An overall donation of Rs 55 million, including Rs. 25 million for PDMA, Balochistan and Rs. 15 million each for PDMAs in KPK and Punjab,

was handed over between August and September 2022.

Moreover, relief goods over Rs. 15 million were directly dispatched to disaster-hit communities in districts Sanghar, Matiari, Kashmore and Sujawal besides UC Ghaibi Dero in Sindh as well as District Kalat in Balochistan. These include more than 4000 ration bags and tents.

PPL's timely financial and in-kind relief efforts for vulnerable communities were highly appreciated by PDMA, elected representatives, local administration and notables. Earlier, PPL has provided generous support to affected communities during earthquakes in 2005, 2013 & 2016 and as well as during floods between 2010 and 2012, with financial and in-kind relief, mobile dispensaries and rehabilitation projects.

Besides, PPL continues to implement its multi-thematic CSR program during the year. Key projects in the area of education and vocational training, include Sui Model School & Girls' College, in Sui, PPL- TCF schools in Kandhkot, scholarship schemes and Vocational Training Institute, Sui.

Public Welfare Hospital Sui, mobile medical dispensaries and annual surgical eye camps around PPL producing fields are meeting the healthcare needs of local communities. Moreover, PPL supplies free-of-cost water and gas to Sui town and has developed several potable water supply schemes in remote areas of Balochistan and Sindh.

Devastating Flash Floods of 2022

Pakistan has recently experienced devastating floods that have caused extensive damage to infrastructure and livelihoods across the affected regions. The floods, occurring amidst the current political situation and a struggling economy, have further exacerbated the challenges faced by the country. Over 20 million people have been left homeless, and the loss of over 1500 lives is a tragic consequence of this natural disaster.

The impact of the floods has been particularly severe in areas where United Energy Pakistan (UEP) operates. Many of these districts have experienced significant crop damage, dealing a heavy blow to the agricultural industry, which is crucial for the local economy. The damage to crops has been substantial, with approximately 90% of them destroyed, leaving little room for cultivating wheat. These areas were once vital contributors to both provincial and national agricultural production, underscoring the urgent need for swift recovery and rehabilitation efforts.

Compounding the situation, the stagnant water resulting from the heavy rains and flash flooding has led to an increase in internally displaced persons (IDPs), who can be seen seeking refuge along

the few dry roads available. Moreover, the floods have also caused damage to infrastructure, including schools and dispensaries, further hampering the recovery process.

Amidst this bleak scenario, United Energy Pakistan Ltd. Has emerged as a beacon of hope for the flood-stricken communities residing in the vicinity of its operations. In collaboration with the Aga Khan University Hospital, UEP has extended medical services to the flood-affected areas surrounding its operations. Over a period of 145 days, medical camps set up by UEP catered to around 100,000 patients, providing vital healthcare services to those in need.

Additionally, female employees of UEP and volunteers distributed approximately 27,000 sanitary packs to females in the affected communities. During the rainfall, several families were supported with hundreds of meters of Tarpaulin, providing them with much-needed shelter. Furthermore, UEP distributed 22,150 mosquito nets, 15,540 ration bags, 4,900 tents, 27,000 blankets and 13 Reverse Osmosis Units (ROs) to communities whose groundwater had become brackish due to climate change.

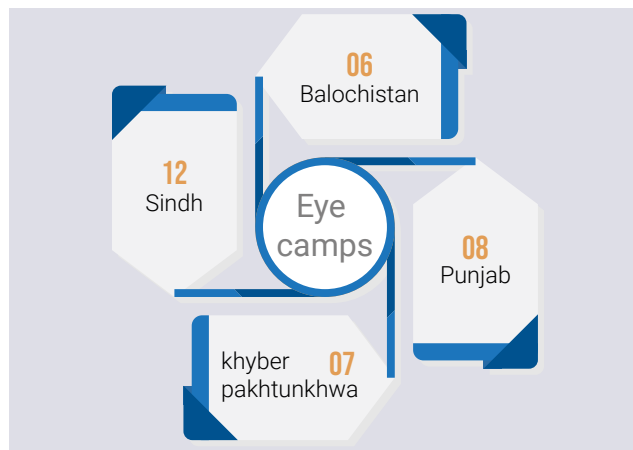

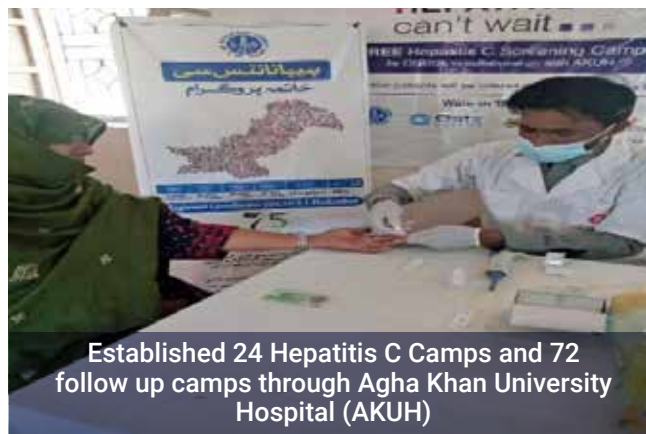

sports, inclusivity and a healthy lifestyle. They also serve as a sports and cultural conservation initiative that celebrate the local heritage and culture of the area, including equestrianism such as horse dancing, polo and tent pegging; as well as traditional team-building sports such as kabaddi; cricket matches and tournaments; martial arts demonstrations; and football matches, etc.

- Education: We sponsor merit-based student scholarships; support women students, build schools; donate educational resources and facilities such as classroom desks and chairs, academic books, laptop and desktop computers.
- Women's Empowerment: We help setup and fund technical vocational training centers for women and donate sewing machines to help support the empowerment of women.
- Health: We sponsored construction of Basic Health Units (BHU), Mobile Health Units (MHU), medical camps and eye camps; build civil dispensaries; donate

ambulances, wheelchairs and healthcare equipment such as digital x-ray systems.

- Water, Sanitation and Hygiene (WASH): We donate water filtration units, construct solar-based water supply schemes, irrigation channels, water harvesting structures, check dams and mini dams, build streets with sanitation drains, and build washroom facilities.
- Environment: We are committed to the environmental priorities of Pakistan's Environmental Protection Agency (EPA). For MOL Pakistan, understanding the environment in which we operate and minimizing our environmental footprint is critical to maintaining our legal and social license to operate in Pakistan. We work continuously to avoid, minimize and mitigate environmental impacts in all our areas of operation. We also aim to improve our waste management and emission performance and manage our impact on water and biodiversity. As such, we also regularly undertake tree plantation campaigns in our areas of operation.





POGC Relief Efforts For Flood Affected People



In the middle of 2022, different parts of Pakistan were ravaged by climate-induced humanitarian disaster in form of massive catastrophic flooding. Brought on by a heavy and prolonged monsoon season that began in June, the floods destroyed vital infrastructure including homes, schools, hospitals, bridges and roads across the country. Among the devastated proportions, District Dadu, the operational area of Polish Oil and Gas Company, came out to be one of the worst affected areas. With an estimated 1 million affected population, about 100 thousand acres of affected crops, 36 thousand damaged houses, and 37 human deaths, the need of immediate live-saving support became utmost significant in this particular district.

POGC, recognizing its responsible, sustainable and philanthropic role for its communities, stepped up in this hour of great challenge and despair. At the onset of this disaster, POGC's community team actively engaged with district administration to provide relief support to the communities. The primary identified relief domain emerged as nutritional support to the traumatized families that were pushed at the brink of food crisis. POGC Management immediately released an aid comprising
















of 1625 comprehensive Ration Bags with capacity to sustain the nutritional requirement of more than 1000 families for 3-4 weeks. This relief dispersal was divided into multiple phases to enhance the efficacy of this effort and ensure its optimal usage.

Another heart-warming gesture in this state of national emergency was the demonstration of compassion and care by our employees by stepping up to the call of serving their fellow citizens that were battling with this unprecedented calamity. An employee sponsored relief campaign was carried out to provide ration to 31 families that were stranded in remote areas with the support of logistical channels developed by Pakistan Army. The empathetic contribution of employees, manifesting the compassion to serve humanity in their hearts, was surely one of the highlights of our relief efforts executed for the betterment of flood affected areas. POGC's response in such dire circumstances earned great appreciation across all the stakeholders, however, the overwhelming sense of gratitude along with sparkling hope in the eyes of people who were left to live under the blue skies, outshined any possible recognition that one could have garnered.
